PACKAGING

Stonkleen AS9 is a concentrated liquid and is available in 5 gallon pails. (FG# 8002A5)

STORAGE CONDITIONS

Store Stonkleen AS9 between 60 to 85°F/16 to 30°C. Keep from freezing.

DILUTION

Stonkleen AS9 is packaged in a concentrated, liquid form. Dilution can be accomplished with hot or cold water.

Light Wax Build-Up I part AS9 to 4 parts water Medium Wax Build-Up I part AS9 to 3 parts water Heavy Wax Build-Up I part AS9 to 2 parts water Extra Heavy Wax Build-Up I part AS9 to I part water

APPLICATION

Apply diluted Stonkleen AS9 liberally to the floor. Allow the solution to stand for 5 to 10 minutes keeping the entire floor area wet. Do not allow to dry. Pick-up the solution with a squeegee equipped wet-vac. Rinse the floor with clear water. After the floor is dry, proceed with the application of a new finish.

Note: Stonkleen AS9 may also be used in a conventional stripping operation utilizing a floor machine equipped with a stripping pad at concentrations of 15 to 20 parts water to one part AS9.

RECOMMENDATIONS

- · The dilution ratios stated are only approximations. Adjust your dilution ratio to optimize cleaning performance or to effect greater economy.
- Use all proper PPE.
